Parents, Students, and Staff Grade High School Safety

This brief research report is one in a series of ancillary analyses of selected data from the annual School Climate Survey conducted by the Department of Research Services. This report is based on data collected in January 1999 and focuses on the opinions of parents, students, and staff on high school safety.

The Selection of Schools

Under the assumption that safety is a greater issue in large high schools, the schools included in this study were restricted to all regular high schools with January 1999 membership levels above 1500 students.

The Survey Questions

The School Climate Survey has three major forms -- one for parents, one for students, and another for staff. All three forms have similar questions regarding school safety. The specific items selected for reporting in this study were:

PARENT FORM:

My child's school is safe and secure.

The school and law enforcement authorities effectively work together to keep my child's school free of:

- ... violence.
- ... gang activity.
- ... substance abuse.

STUDENT FORM:

I feel safe at my school.
Violence is a problem at my school.
Gangs are a problem at my school.
Student drug and alcohol use are problems at my school.


STAFF FORM:

At my school I feel safe and secure. My ability to do the best possible job at this school is limited by:

- ... school violence.
- ... student gang activity.
- ... student substance abuse.

The Coding of Responses

The survey recipients were asked to respond to each item on a five-point scale from *Strongly Agree* to *Strongly Disagree*. The safety items on some forms were worded in the positive sense (strongly agree is a positive indication for the school) and on other forms in a negative sense (strongly disagree is a positive indication for the school). For this analysis, all responses were recoded to make positive indications unidirectional. Furthermore, the response categories were recoded into grade equivalents using the following scale.



This recoding into the grading scale allows the representation of single-number group averages in a format that is readily interpreted.

Additional Objective Data

The School Climate Survey asks for opinions only. Although opinions make up a real aspect of school environment, they may differ from the factual situations at the schools. For comparison purposes, objective data concerning the safety of the school environments are included in this report. These data come from the 1998-99 School Environment Safety Incident Report as reported in the annual School Advisory Council Report. Generally, this report documents the number of incidents of crime and violence occurring on school grounds. The categories

reported here include *Substance Abuse* (combined drug and alcohol incidents), *Fighting*, *Disorderly Conduct*, *Threat/Intimidation*, and *Total* number of reported incidents for all classifications. The numbers reported here are relative frequencies per 1000 students at each school.

Discussion of Results

The data are presented in the table below. The schools are ordered with respect to the relative total number of reported incidents of crime and violence. Perhaps the most striking aspect of the results is the generally positive grades given to most of the high schools by all survey respondent groups. Nonetheless, there is considerable variation in the opinions of school safety across the different high schools. The staff, as a

group, tend to grade the safety of the schools slightly higher that either the parents or the students. Still, the ordering of the schools shows appreciable agreement between staff and students, with parents only slightly differing. The reader should bear in mind that the Safety Report may not reflect all incidents of violence and crime actually occurring at any individual school. Likewise, discrepancies between real and perceived safety environments may indicate nothing more than public relations problems for the schools. However, in general, the ordering of schools based on the opinions of survey participants is in agreement with the objective ordering based on reported incidents with few exceptions, and the members of the school community appear to be mindful of real safety concerns.
